### **Eligibility for CHC30121 Certificate III in Early Childhood Education and Care/CHC50113 Diploma of Early Childhood Education and Care**

- Must be a Queensland resident.
- Must be over the age of 15 years (under 18 years requires parent/guardian consent).
- Must no longer be in high school.
- Must be an Australian or New Zealand citizen or Australian permanent resident (including humanitarian entrants) or temporary resident with necessary visa and work permits on the pathway to permanent residency.
- Must not have or be enrolled in a Certificate III level or higher qualification (for Certificate III Guarantee programs), Certificate IV or a Diploma level qualification (for Higher Level Skills Program), not including qualifications at school and foundation programs.

### **Eligibility for UEE40420 Certificate IV in Instrumentation - Electrical**

- Must be a Queensland resident.
- Must be over the age of 15 years (under 18 years requires parent/guardian consent).
- Must no longer be in high school.
- Must be an Australian or New Zealand citizen or Australian permanent resident (including humanitarian entrants) or temporary resident with necessary visa and work permits on the pathway to permanent residency.
- Must have a copy of their electrical trade certificate (must state Certificate III).
