Eligibility Criteria

Career Start – General Training Pathway

- Must be a permanent Queensland resident
- Aged 15 years or older and not enrolled in school
- Must be an Australian or New Zealand citizen, Australian permanent resident (including humanitarian entrant), or temporary resident with appropriate visa and work permits on the pathway to permanent residency
- Not currently enrolled in another qualification (excluding foundation skills)
- Not have completed a Certificate III or higher within the past 10 years
- Not exceed two funded apprenticeships/traineeships across Career Start, Career Boost, and SATs in the last 10 years

Career Boost – General Training Pathway

- Must be a permanent Queensland resident
- Aged 15 years or older and not enrolled in school
- Must be an Australian or New Zealand citizen, Australian permanent resident (including humanitarian entrant), or temporary resident with appropriate visa and work permits on the pathway to permanent residency
- Not currently enrolled in another qualification (excluding foundation skills)
- Not have completed a Certificate IV or higher qualification in the last 10 years
- Can access up to two funded skill sets in addition to one funded qualification

Refunds and Policy Notes

- Fee exemptions may apply for students facing financial hardship.
- Students are encouraged to complete post-training surveys issued by DTET for quality improvement.
